Financial Report July - September (MDN)

Approved

2024 new grant fund numbers will need to be created (900 series) There will be a total of 4 new funds created.

4922 will bed moved into 1100 series (1122) with alternating years. This comes by recommendation of the State.

Project income collections are doing very well, staff has done a great job continuing to collect client fees.

## JDAI – Judge Schein

Lori Thompson and Magistrate Berish recently attended training. JDAI received a performance grant in the amount of \$65K and must be used by 6/30/24.

Felony Diversion – Sam Myers

Currently have 64 on Felony Diversion. Still continued with a high success rate- things are going well.

Reminder by MDN: IDOC is not funding the diversion program in 2024. That was cut from the IDOC funding. This will have to be covered by Prosecutors Office.

Pretrial – Lenny Stepp

Currently have 440 on PT supervision. Updates sent to IOCS on 9/20/23 for certification.

PT Fees brought up for discussion (by statute can charge \$25-\$100) w/ monthly fee and admin fee. Lenny presented that this could be an opportunity to generate some income, not setting a blanket fee for everyone.

Judge Petit expressed the original concern from IOCS about the charging of fees. Judge Petit expressed he would like a procedure in place as far as questioning a client/defendant about the ability to pay and be charged fees.

Discussion tabled until further notice.

Home Detention – Matt Williams Currently have 113 units out 95 – HD 1 – GPS post sentence 6 Juvenile 11 PT

Alex Murdock has joined us as our new field officer. He is doing an excellent job.

Residential Facility Update – Annette Bowden

Work Release closed as of October. No current beds due to construction.

Annette and Jana will be working on PREA policies and shadowing other counties beginning November 1<sup>st</sup>.

Drug Court Update – Katie DeVries

Obtained provisional certification 1 month ago. Since provisional there have been 15 potential clients screened. All but 3 were accepted as potential clients for drug court. Pending plea offer, sentencing, etc.

Reviewing the option of a violation track – seeking approval from IOCS. This would start out with Circuit Court cases and expand as allowed. Recommended IDOC sentenced – stayed sanction and placed not drug court for completion.

Quality Control Update – Katie DeVries/ MDN

80% Completion Rate

Adhering to 4:1 sanction/incentive ratio. Case managers are currently running at a 5:1 ratio which is excellent.

We have received praise from IDOC and Court Services towards the department and what we have in place and what we are doing with our clients.

Judge Petit- Katie DeVries was appointed as the new A/D Director. She accepted the position.

2022 Financial Audit

No findings

Unspent grant funds \$49,776.44. This amount will be reflected as a less amount in our 2024 grant award.

## **CSAMS**

CC staff stopped providing CSAM case management approximately two years ago. There is potential benefit for case managers to do service contracts and become CSAM certified. First quarter of 2024 will begin the CSAM process with current staff.
