Distribution Process of Grant –

1. Amount of Grant will be received from the Auditor for current fiscal year.
2. Funds will be divided into the three categories intended by the grant: Prevention/Education, Criminal Justice, and Intervention/Treatment. 30% going into each category with a 10% operating category. This should be revisited each year as funds diminish.
3. Funds will be available in the category till November of that fiscal year. Remaining funds of all categories, at that time, will be available to applicants who may have received partial funding and request more for their project. Remaining funds will be added to the next fiscal year's grant amount, for division into the three intended categories for next year.
4. Applicants may apply on the odds numbered month for consideration. Grants may be fully or partially funded. If funding is exhausted in that category applicants may reapply in November of that year for additional funding.

Jane will contact the LCC for their approval. Packets will then be mailed out to entities.

Motion to approve the grant distribution was made by Daniel Askren, second was made by Lindsey Winger. Motion carried.

Update JRAC 2nd Quarter Reporting – Dani Snider

A quarterly report is required reporting statistics of those in the Criminal Justice System/Home Detention (WCRCC) for Fountain county. WCRCC is regional, containing Fountain, Warren, Montgomery, Parke, and Vermillion counties. It is difficult to report statistics based on single county questions. She has spent much time communicating with the DOC trying to reconcile the figures.

New Business:

Mapping Walk Through – Lindsey Winger, Probation

Due to the lengthiness of the Opioid Grant information Mapping Walk Through – Probation will be presented at the November meeting.
