Good afternoon, Ms. Greene:

Judge Dena Martin forwarded your email to me for review and response, as I serve as the county's public records officer. Greene County uses a standardized form with all public records requests, as permitted by statute. The form serves a variety of internal purposes helpful to me and also assures that we have complete, accurate contact information from the requester. I have attached a copy of that form and request that you or one of your staff complete at least the requester information section of the form and return it to me. You are welcome to attach your original email request to that form or to itemize your requests in the space available on the form. The form is fillable onscreen.

The information you have requested is of course subject to the Access to Public Records Act, and I have asked Judge Martin to gather the information (or to have the board president or secretary provide the

information) pending your return of the county form. I anticipate being able to send that material within 5-7 calendar days or less from the time I receive the completed form. Because the information will be provided electronically, copy fees do not apply. If you review the information and have additional request, feel free to contact me directly as I will serve as your public records contact going forward.
