#### Minutes from June 2, 2023

June 2, 2023, minutes were reviewed, and a motion was made by Mr. Holtsclaw and a second from Sheriff Dallaire.

#### **Updates**

# **Greene County Superior Court**

Judge Martin advised that TJP is still looking for participants. Ms. Noel has been sitting in on Initial Hearings to find eligible individuals. Some of the mental health issues that are being seen are too much for eligibility.

Judge Martin advised that ED statutes were changed, and she has met with most of the stake holders in the County and, other than a couple of issues early on, things are on track. Judge Martin also stated that she and Judge Allen are looking at changing the local rules. Those changes will be posted and there will be a comment period.

## **Greene County Prosecutor's Office**

Mr. Holtsclaw stated that there have been changes in his office. Ed Linneweber is now the Chief Deputy Prosecutor, replacing Tim Cain. Carrie Speer is back after taking the Bar Exam and is working on building her own caseload under the other Prosecutors until early October when, pending her exam results, will be sworn in.

#### **Greene County Community Corrections**

Ms. Wininger advised that she has had changes in her staff. Field Officer Johnson took a position with the Jasonville Police Department and case manager Tammy Woodall retired. Haylee Rupp is a new case manager. Lynn reports that her numbers are low right now. She also provided a copy of the SEA 9 for the council to review.

# **Greene County Probation Department**

Mr. Pate advised that his office is preparing to go to the probation conference in two weeks. He stated that all but one of his probation officers will be attending this year.

## **Greene County Circuit Court**

Judge Allen expressed his appreciation for everyone around the table and for working so well with each other. He also praised his staff and their longevity to the Greene Circuit Court. Kudos were also given to the Security Department at the courthouse. Sheriff Dallaire and Judge Martin echoed the kudos for the Security Department.

# **Legacy Associates**

Ms. Hoesman continues to look for bachelor's level staff. She stated that she recently attended a Suicide Awareness meeting in Linton. She states that she learned there is some funding through the Department of Health for health and mental health. Not for Profits and community mental health agencies will qualify for the money. Could possibly go through the foundation to apply for funding. The money could be used for suicide prevention; someone would go to the site of a suicide and help the family process what needs to be done after a suicide. Local people would be trained to be on site. Ms. Noel questioned if the money could be used for Mental Health First Aide; the funding for the program is about out. Deb will check into this.

# Greene County Public Defender's Office

Ms. Dyer stated that her office has made a conditional offer to their intern; her swearing in will be in early October, pending her bar exam results. Jaim Sutton is now a full-time equivalent taking a higher case load and Tim Shonk is still working a ¾ contract. She has also been approved to hire more support staff. The position will be a full time secretary/paralegal position. Ms. Dyer will be attending a conference in October on alternatives for competency restoration.

## **Greene County Council**

Ms. Zimmerly stated that the Council just finished the budget hearings. She states that the process went well.

#### **Greene County Sheriff's Department**

Sheriff Dallaire stated that his department is looking for deputies; he has lost a few this year and hasn't had much interest from job posting. He states that his department is also losing its Investigator. As of August 30, Q360 advised the Sheriff that they have hired a provider. The provider will be split 50/50 with Pike County; the end of October will be a possible start date. This provider will take the place of the weekly provider they are currently using. Sherriff states that most days there are 1 to 3 people on active suicide watch within the jail. He is looking into some technology that would help with monitoring these individuals.

#### **Greene County Court Services**

Ms. Noel stated that her two jail classes are going very well. The participants are doing great with doing homework, engaging in the class, and participating appropriately in class. She is looking into a transitioning from incarceration back into society program and also a family and parenting program that is specifically designed for men.

Mr. Holtsclaw made a motion for reimbursement for the breakfast provided. Mr. Michael seconded the motion.

#### Minutes from March 3, 2023

March 3, 2023, minutes were reviewed, and a motion was made by Sheriff Dallaire and a second from Prosecutor Holtsclaw.

#### **Updates**

#### Q 360

Sheriff Dallaire provided an update on the progress of getting the Q-360 program going in the jail. Julie Venus, with the program, has advised the Sheriff that she currently has 3-4 qualified applicants, and the interview process should be starting anytime, if not already in progress.

#### Therapeutic Justice Program (TJP)

Ms. Noel advised the council that the following have all been completed for the TJP: Policy and Procedures Manual, Participants Manuel, Plea Agreement, and the Participant's Agreement. Everything is ready to submit to IOCS for approval and certification. Ms. Noel also advised that the TJP board has identified a possible first participant. Judge Martin

discussed that the criteria to be accepted into the program will be difficult; the majority of individuals will not qualify.

#### Prosecutor's Office

Prosecutor Holtsclaw stated that he is happy with the progress of TJP. His law clerk, Carrie, has graduated and is preparing for the bar this summer. He hopes to have her back this fall. His office is also looking to change the caseload distribution. Instead of distributing based on Circuit or Superior Court he wants to distribute based on areas of prosecution. The office will be holding active shooter training in the school. Discussion was held about the possibility of having courthouse wide active shooter training. The Sheriff's department could possibly get this coordinated. Prosecutor Holtsclaw also advised that Todd Corn will be retiring at the end of June.

#### **Probation Department**

Mike Pate advised that his office is fully staffed, and they have recently added a second juvenile probation officer, Jennifer Wilson. Mr. Pate also advised that he will be meeting with the Judges to update the probation orders.

## **Community Corrections**

Lynn Wininger provided a copy of the SEA 9 quarterly report for the council to review. Ed Michael has advised Lynn that five people on the CC advisory board are coming to the end of their terms, some of them will need to be replaced; discussion was had as to possibilities. Lynn also advised that Tammy Woodall will be retiring at the beginning of July.

### **Legacy Associates**

Ms. Hoesman advised that she would like to hire more therapists in her office. She has recently hired a new Case Manager, Jenny Waggoner. Ms. Hoesman also stated that her intern, Shawna, has finished her practicum with the office.

## Greene County Public Defender's Office

Ms. Dyer advised that Levi Baysinger will be leaving her office June 16. Jamie Sutton will become a full time contract public defender, pending Board approval. Her office intern, Chloe, graduated and is preparing for the bar this summer. Ms. Dyer stated that her office is screening their new clients for potential TJP participants.

Mr. Holtsclaw made a motion for reimbursement for the breakfast provided. Sheriff Dallaire seconded the motion.
