- Appointed members of the Advisory Board shall be appointed for a term of four years. • The criminal defense attorney, the ex-offender, and the victim or victim advocate shall be appointed for a term of four years.
- Other members serve only while holding the office or position held at the time of appointment. The circuit court judge may fill the position of the judge having juvenile court jurisdiction by self-appointment if the circuit court judge is otherwise qualified.
